From the Chairman's Desk

To My Fellow Residents:

This is just a quick note of to review the past year for the Town and what the Town is looking forward to in 2022.

2021 was the real beginning of recovering from the trials we all faced in 2020. I know that each of us has had to deal with them in our own way, and it has been incredible to see how friends and neighbors have pulled together and looked after one another. In April 2021 I was honored to be re-elected as your Town Chairman and am continuing to work on your behalf to help Hortonia grow responsibly and prosper for years to come.

Major Projects that we completed this year include: Repaving and adding new culverts to the Town Hall Parking lot, as well as excavating around the Town Hall to redirect water that was causing flooding in the area. Repaving Everts Lane as well as continuing to spot repair and keep up with our road maintenance schedule. Completing the update to our Zoning Ordinance, hiring a new Town attorney and appointing a Zoning Administrator. We have also contracted a New Garbage Pickup service. (More on that on Page 2)

A Few of the the Projects the Board is looking forward to working on include: Updates to the Town Hall, collaborating with the County Task Force on Rural Internet/Broadband, and Repaving and repairing roads. Our Clerk will be working on overhauling the records retention for the Town and working with the Zoning administrator to make sure the County and Towns records match and are updated.

I also want to take time to send a thoughtful message of hope for better times ahead. Covid continues to be a challenge to us all, not only in the form of losing people we love, but also in the form of stress on so many parts of our everyday lives both economically and personally. Together we will continue to move forward and be stronger then ever. To that end The Board voted unanimously to not raise either the Town's Tax Levy or the Garbage assessment this year to help with costs.

NEW for 2022 GARBAGE AND RECYCLING

The Town has contracted with HARTERS Fox Valley Disposal llc, with our first pickup scheduled for **Monday Jan 3rd, 2022**

All Municipalities in Outagamie County will now need to have automated collection so each residence will be receiving new Carts for both Garbage and Recycling on or around **Dec. 16th.**

Attached to the carts you will find information including the new collection schedule and where carts need to be placed for collection.

ONLY ITEMS IN THE CARTS WILL BE COLLECTED. ANYTHING LEFT ON THE SIDE OF THE CARTS WILL NOT BE TAKEN.
