## Clerk's Report and minutes:

### Here From the Floor:

Resident K Brown has been talking with people from the Town for two years regarding a nuisance property next to hers.

He has emails from Glenn from September of 23, dealt with Jeff Sanders, and talked to Paul Hanlon in September of 2024.

The property in question received a registered letter giving the property owner 30 days to clean it up, but it has only gotten worse.

Attorney Parmentier suggested pursuing an in-junctional suit in County Circuit Court and discussed the new Nuisance ordinance that was enacted last month. Much stronger "teeth" to pursue action.

Enforcement mechanisms are complicated, considering costs of circuit court.

More actions will be discussed in the closed session.

The attorney reviewed what closed sessions entailed and the circumstances under which they were allowed.

(The reason for closed sessions is to discuss strengths and weaknesses without the other side hearing the weaknesses. The goal is not to keep secrets, but to keep strategic things confidential in the interest of the town.)

Constable Report: Someone dropped off a dog with a leash at Rick's house. He has adopted it.

There were horses loose-out on 15, and there are concerns about the number of animals and whether it's being run as a business. Nine horses got out one day.

#### **New Business:**

Road Maintenance and County Projects

Road condition by the railroad tracks on Lower Givens is bad.

The plan is to patch it temporarily until the county builds their buildings and determines the driveway location.

The town has money to fix the road up to the railroad fence. The county bought 11 acres from the state for \$48,000 for an Equipment Storage Garage.

Spectrum Issues-poor repair of right of way following installation.

Contractors were leaving stones and rocks all over the place after digging.

Spectrum was contacted and claimed to have cleaned up the mess. Chair will contact them again

There is a bump in the blacktop where they bored underneath it on Everts Lane.

The Evergreen sign on 45 needs a new pole and sign.

Working on yield signs at the railroad tracks, coordinating with the railroad.

## Flagpole Replacement

The current flagpole is bent and needs to be replaced. A new flagpole will cost \$1250 with \$355 for installation. There is a veteran-owned company in Wisconsin that sells flag poles for \$250.

A motion was made and seconded to approve the new flagpole. Carried
